

# JOB DESCRIPTION: Marine Futures Internships North Wales X2

Salary: £12.00p/h (Real Living Wage) with a 6% Employer Pension Contribution
Working Hours: Full Time (35hrs per week) for the period 17th June – 13<sup>th</sup> December 2024
Location: Both Internships will be primarily based at NWWT HQ in Bangor with a mixture of fieldwork across North Wales and some travel to London.

## 1. BACKGROUND & OVERALL PURPOSE OF THE POST

The Marine Futures North Wales Internship programme offers a unique opportunity for candidates interested in a career in the marine environment to gain skills, knowledge and experience across a variety of marine sectors; helping to inform and shape future career opportunities.

The Programme is funded by The Crown Estate, project managed by North Wales Wildlife Trust and run in partnership with The Crown Estate, M-Sparc and Menter Môn. Each partner organisation provides opportunities for the intern to develop on-the-job skills in specialist areas including, marine conservation advice, sustainable fisheries, renewable energy development, marine policy, and community engagement. Through the programme the intern will be offered experience and a balanced view on a career in the marine environment and how different sectors can work together. The intern will get the chance to undertake an independent research project focussing on a topic that is relevant to all partners. Additional activities will include stakeholder engagement, creating virtual educational outreach materials and ecological fieldwork.

## 2. PRINCIPAL RESPONSIBILITIES

- To undertake a joint independent research project for the partner organisations
- To communicate the outcomes and recommendations from the research project through a written report and oral presentation for all partner organisations and relevant stakeholders
- To gain a greater understanding of careers relating to the marine sector
- To improve knowledge of renewable energy developments and some of the environmental, social and economic considerations associated with these
- To gain a thorough understanding of some of the environmental issues facing UK coasts and seas, especially in relation to the North Wales and the Irish Sea
- To gain scientific survey and GIS experience alongside the partner organisations
- To deliver marine awareness and educational outreach alongside the North Wales Wildlife Trust
- To assist the North Wales Wildlife Trust with key conservation and restoration projects
- To gain greater insight into the consenting process of marine renewable energy
- To gain an understanding of remote working and online meetings by working with colleagues from each of the partner organisations, building a network of contacts in the marine sector
- Producing information, resources and promotional material as required.
- Undertaking other duties and responsibilities as appropriate and consistent with the objectives of the programme and the respective organisations.
- Ensuring that H&S Procedures are followed and implemented as appropriate

## 4. TERMS & CONDITIONS

Salary: Real Living Wage – £12.00 per hour, plus Employer Pension Contribution of 6%.

**Duration of post:** 5 days per week for 6 months starting 17<sup>th</sup> June 2024 and finishing 13<sup>th</sup> December 2024. Interns will be expected to commit to the full length of the programme.

**Hours per week:** The intern will be paid hourly for 35 hours per week, based on working 7 hours a day, 5 days per week. Hours will normally be worked between 9.00 am to 5.00 pm, Monday to Friday, however, some out-of-hours work may be required, for which time off in lieu will be given.

Holidays: 30 days per annum, including public holidays.

**Place of work:** Both Internships will be primarily based at NWWT HQ in Bangor with a mixture of fieldwork across North Wales and some travel to London.

**Expenses:** Interns may be expected to arrange and pay for their own accommodation and travel for the duration of the internship. Interns will be reimbursed for travel as part of the programme from their place of work (for instance when travelling for events, meetings and surveys). In some circumstances, additional subsistence expenses may be incurred in connection with the programme, these will be reimbursed where appropriate in-line with North Wales Wildlife Trust's expenses policy and approval must be sought from the Project Manager before expenditure.

All travel and accommodation requirements for trips to London (if possible during the internship) will be covered by The Crown Estate. Any additional expenses, where reasonable, such as subsistence for travel to London, will be reimbursed.
